

THE NFL PRO BOWL VIP EXPERIENCE SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The NFL Pro Bowl VIP Experience Sweepstakes (“**Sweepstakes**”) is sponsored by Lowe’s Home Centers, LLC (“**Sponsor**”), 1000 Lowe’s Blvd., Mooresville, NC 28117 and is administered by Prize Logic, LLC, (“**Administrator**”), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on October 28, 2021 at 8:00 AM Eastern Time (“**ET**”) and ends on November 24, 2021 at 11:59:59 PM ET (“**Sweepstakes Period**”). The Administrator’s computer is the Sweepstakes official clock.
2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years old and age of majority in their state of residence at the time of participation; a PRO (defined as someone who works for or provides services in any of the following industries: construction, home improvement/repair, property management, and/or maintenance management sectors, or other sector as determined by Lowe’s in Lowe’s sole discretion) (“**PRO**”); and who are a Lowes.com registered Business account holder at the time of entry (it is free to register for a Lowes.com account), subject to [Lowes.com Terms and Conditions](#). Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising, the NFL Entities (defined below) and promotion agencies (collectively, “**Sweepstakes Entities**”) and each of the foregoing’s immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant’s residential address and Lowes.com e-mail address will be the physical address and e-mail address submitted at the time of Sweepstakes entry. Entrants will not be allowed to change their physical address or e-mail address after submission.

3. **HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible entrant may visit LowesPROvemberSweeps.com (“**Website**”) and complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials), valid e-mail address (e-mail must be the e-mail address associated with his/her Lowes.com Business account), phone number, street address (no P.O. Boxes will be allowed), city, state, and zip code. Upon the successful submission of the registration information, an entrant will receive one (1) entry into the Sweepstakes.

Entry Limit: There is a limit of one (1) entry per person per day. If more than one (1) entry per day is received from the same person, telephone number and/or e-mail address the entries may, at the Sponsor’s sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor’s sole discretion, may not be eligible to win a prize. A “day” is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on a calendar day during the Sweepstakes Period, except on October 28, 2021 when a day is defined as starting at 8:00 AM ET and ending at 11:59:59 PM ET.

IMPORTANT: MESSAGE AND DATA RATES MAY APPLY IF AN ENTRANT ENTERS THIS SWEEPSTAKES ON HIS/HER MOBILE DEVICE. NOT ALL MOBILE TELEPHONE/WIRELESS PROVIDERS CARRY THE SERVICE NECESSARY TO PARTICIPATE IN THESE SWEEPSTAKES. ENTRANTS SHOULD CONSULT THEIR WIRELESS PROVIDER'S PRICING PLANS. RANDOM DRAWING: On or around November 29, 2021, the Administrator will randomly select five (5) potential grand prize winners, one hundred (100) potential first prize winners, and two hundred fifty (250) potential second prize winners from all eligible entries received. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:

A. Grand Prizes (5): Each grand prize is a trip for two (2) to the 2022 Pro Bowl Experience in Las Vegas, Nevada (each a “**Grand Prize**”). Trips include round-trip coach class air transportation from a major commercial airport near winner’s residence to Las Vegas, Nevada for winner and one (1) adult guest, three (3) nights hotel standard accommodations (single room/double occupancy), a VIP experience (includes an the opportunity to engage with NFL legend(s), a premium NFL swag bag, and exclusive photo opportunities), access for two (2) to the 2022 Pro Bowl Experience on February 6, 2022, \$1,560 to help offset taxes, and \$500 Visa Gift Card (for winner only). Winner’s guest must be eighteen (18) years of age or older. If the winner elects to travel or partake in the Grand Prize without a guest, no additional compensation will be awarded to the winner. Winner and guest must travel on, February 4, 2022 and return on February 7, 2022 or Grand Prize will be forfeited. Winner and guests must travel on the same itinerary. The actual value of the trip may vary depending on point of departure and fluctuations in the cost of air transportation. Any difference between the estimated ARV and the actual value of the prize will not be awarded. If winner resides within a 100-mile radius of destination, ground transportation may be provided in lieu of air transportation, and no compensation will be provided for any difference in prize value. Travel dates are subject to availability; blackout dates and other restrictions may apply. Each winner and guest are responsible for having valid travel documents including government identification and/or passports. Winner is responsible for all travel expenses not included herein, including airline baggage fees, gratuities, meals, and any other incidental costs or expenses related to participation in this prize. The Sponsor and Sweepstakes Entities will have no liability and will not be required to award a prize if a winner or guest tests positive for COVID-19, is unwilling or unable to participate in the screening or other protocols.

Sponsor and Sweepstake Entities are not responsible if event is delayed, postponed, or canceled for any reason. Winner will not receive compensation from Sponsor for prize that the winner is unable to use due to cancellation of the event, but event may be subject to standard rain-check policies and procedures set by the issuer. - B. First Prizes (100):** Each first prize is an Official Wilson Duke NFL Football (each a “**First Prize**”). No more than one hundred (100) First Prizes will be available in the Sweepstakes. The ARV of each First Prize is \$120.
- C. Second Prizes (250):** Each second prize is a \$100 Fanatics NFL Shop Electronic Gift Card NFL shop gift card (each a “**Second Prize**”). Terms and conditions of gift cards apply. Valid only at NFLShop.com. Except where required by law, cannot be redeemed for cash or cash equivalent, returned, reproduced, modified, sold, traded, refunded or replaced if lost or stolen. Not valid for any other gift cards, codes or e-gift cards or on previous purchases or returns. No cash back unless required by law. If the value of your purchase exceeds the available gift card / e-gift card balance, you must pay the excess at the time of purchase. Any unused amount will be applied when you re-enter your gift card / e-gift card during your next purchase. All purchases are subject to the NFLShop.com Terms of Use, which may change at any time. Gift cards/e-gift cards are issued by Fanatics Retail Group Fulfillment, LLC. No more than two hundred fifty (250) Second Prizes will be available in the Sweepstakes. The ARV of each Second Prize is \$100.
- D. Total ARV:** The total ARV of all prizes is \$56,500
- E. Odds of Winning:** The odds of winning a prize depend on the number of eligible Sweepstakes entries received during the Sweepstakes Period.
- F. General Conditions:** There is a limit of one (1) prize per person. In no event will more than five (5) Grand Prizes, one hundred (100) First Prizes, and two hundred fifty (250) Second Prizes, be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received.

6. HOW TO CLAIM A PRIZE: The potential winners are subject to verification of eligibility and compliance with these Official Rules After the random drawing, Administrator will notify the potential winners via e-mail at the e-mail address provided at the time of registration. Each potential Grand Prize winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) calendar days from the date of attempted notification or his/her Grand Prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor’s sole and absolute discretion. Failure to provide all required information and a signature on the documents within the stated time period may result in forfeiture of a winner’s right to claim his/her prize, and may result in the prize being awarded to an alternate winner, if time permits. If a potential winner is disqualified, found to be ineligible or not in compliance

with these Official Rules, declines to accept a prize, the respective prize may be forfeited. If a prize is forfeited, the prize may be awarded to an alternate Winner, selected in a random drawing from among all remaining eligible entries, as determined by Sponsor in its sole discretion. Any portion of a prize not accepted by winner will be forfeited. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for his/her prize won. Sponsor will issue an IRS Form 1099-MISC for each Grand Prize winner. All other costs and expenses not expressly set forth herein shall be solely each winner's responsibility. The prizes will only be awarded to a verified Winner.

Sponsor will attempt to notify each potential winner as set forth above, but neither Sponsor nor its parent or affiliates are responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including any winner notification e-mail, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded. THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN NORTH CAROLINA. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN MECKLENBURG COUNTY, NORTH CAROLINA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY'S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
